



## THE KINGDOMS AND LANDS OF THE CROWN OF RUTHENIA AND THE LANDS REPRESENTED IN THE COUNCIL OF KARNIA

---

*A bill on the social regularization of citizens from the State of Delvera and Empire of Occidia,  
and other special provisions.*

---

We, the III Legislature of the Imperial Diet of Karnia-Ruthenia, assembled to integrate the Karno-Ruthenian society, by the hands of the Sovereign, decided the following, and present to the III Legislature, in the current format, to be considered and approved, the following:

### **ARTICLE 01**

Considering the previously republican characteristics of the State of Delvera, their society lacked of titles of nobility, that are to be introduced by this act for previous meritorious actions. While the Occidian society were developed under the monarchical regime, their aristocracy was not, until the moment, merged to the national aristocracy, what will be done through the present act.

### **ARTICLE 02**

Regarding the Delveran citizens, for their duty to People and Country, the development of their Nation and the union with the Empire, are recognized, for their service:

- a) To *John Dylan Callahan*, the title and style of *His Illustrious Highness, Margrave Callahan*.
- b) To *Jordan Brizendine*, the title and style of *His Illustrious Highness, Margrave Brizendine*.
- c) To *Casey Pemberton*, the title and style of *His Illustrious Highness, Margrave Pemberton*.
- d) To *Amy Brizendine, Adam Brizendine, Cole Brizendine, Dustin Goss, Quinten Failor* and *Michael Holloway*, the unique style of *Illustrious* while inactive citizens, and eligible to a noble title if return to activity.

All the titles created in the present article and the titles to be created in the terms presented at item d, are hereditary. Their consorts are entitled to same rank and style, and their children with the rank and style of counts.

### **ARTICLE 03**

Regarding the Occidian citizens, for their duty to People and Country, the development of their Nation and the union with the Empire, are established, for their service, tradition and history:

---

#### **House of Hartmann-Peters**

- a) To *Wilhelm von Hartmann-Peters*, the title and style of *His Majesty, King in Illinois and Prince of Hartmann-Peters, Margrave of Kandahar*.
- b) To *Shaun Wilhelm von Hartmann-Peters*, the title and style of *His Highness, Crown Prince in Illinois, Prince of Ohio and Hereditary Prince of Hartmann-Peters*.

- d) To *Kasey Honings*, the title and style of *His Highness, the King in Connecticut*.

All the titles created in the present article and the titles to be created in the terms presented at item d, are hereditary. Their consorts are entitled to same rank and style, and their children with the rank and style of the title immediately under their rank.
