E, the EMPEROR OF KARNIA AND KING OF RUTHENIA, King of Bessabia, King of Acrin, King of Horvatia, Szolnók, Geza, Letingia, Escandia, King of Jestia, etc.; Archduke of Karnia, Grand Duke of Gaussland, Caledonia; Duke of Ladislavia, Hoheneinsamkeit, Weißeswasser, Csorna, Chedowski, Balaton; Grand Prince of Karcag, Margrave of Luftrein, Duke of Persenburg, Götzödorf, Mohács, Pannonhalm, Podenbrad, Gyalla, Oswiencin, Zallanta, Cieszpreg, Fertodin, Rugoz, Árpád; Princely Count of Bihar, Tamaz, Koberg, Gerizia, Grevenia; Prince of Thomaz-Rocha, Bersód; Margrave of Upper and Lower Lusitia; Count of Heves, Feldkirchenberg, Brevento, Szentes, etc.; Lord of Fürstenbergserdboden, Kazin, etc., etc. etc.,

WHEREAS IGOR LENCOVIC has applied for a Certificate of Naturalization as a Karno-Ruthenian citizen, has satisfied us that he has fulfilled the conditions for the grant of such a Certificate prescribed by the Imperial Constitution.

NOW THEREFORE, WE, the Emperor-King of Karnia-Ruthenia, hereby grant, in pursuance the terms exposed by the Imperial Constitution, this Certificate of Naturalization, whereby, subject to the provisions of that Constitution and of any other law affecting the rights of naturalized persons, the abovenamed applicant shall, as from the date upon which he swears or affirms allegiance to His Imperial and Royal Majesty, the Emperor-King Oscar the First, his heirs and successors, and swears to or affirms that he will observe faithfully the laws of the Karno-Ruthenian Empire and fulfill his duties as a Karno-Ruthenian citizen, become entitled to all political and other rights, powers and privileges, and become subject to all obligations, duties and liabilities to which a Karno-Ruthenian citizen is entitled or subject, and have to all intents and purposes the status of Liberian citizen and Karno-Ruthenian subject.

Considering the patient's demand to be a civil mandamental action whose purpose is to rectify his name, that is, for purposes of protection of civil material right, I acknowledge *ex officio* my incompetence to first receive the petition. Thus, considering the vacancy of magistrates in the Persenburg High Court, and the maxim according to which *in eo quod plus est semper inest et minus*, understood in this concrete case from article 2 of the Temporary Constitutional Provisions Act, I hereby constitute a Summary Court to prosecute and judge the author's claim.

Under the terms of article 109 of the Constitution, I appoint Mr. Johannis Sauerbronn, citizen registered under No. 235 of the Civil Registry of the Empire, of unblemished reputation and well-known legal knowledge, to be the Summary Judge.

INTIME the notarial authority to refer the case to his jurisdiction.

DONE and SENT the present Office in this Imperial City of Persenburg-Götzödorf, Capital of Karno-Ruthenian Empire, in the twenty-eighth day of January of two thousand and nineteen.
