



## THE KINGDOMS AND LANDS OF THE CROWN OF RUTHENIA AND THE LANDS REPRESENTED IN THE COUNCIL OF KARNIA

---

*A bill to guarantee automatic transmission of citizenship to consorts, ancestors and descendants  
of Karno-Ruthenians.*

We, the III Legislature of the Imperial Diet of Karnia-Ruthenia, assembled to integrate the Karno-Ruthenian society, by the hands of the Sovereign, decided the following, and present to the III Legislature, in the current format, to be considered and approved, the following:



### **INTRODUCTION**

Embedded in the desire to strengthen our personal and family ties in favor of building a welcoming nation, which has family and unity as its basic principles, this law is presented to include, among the constitutional provisions, another provision for granting citizenship, namely, to consorts, as well as ascendants and descendants in a direct line, upon simple request.



### **OBJECTIVE**

The objective of this law is, as mentioned previously, to strengthen the personal ties between members of the same family to the ties that unite us as fellow citizens, to truly be a family not only of nations, but of citizens who carry with them the burden and the privilege of increasing not only the number of citizens and other demographic reflections, but of raising our prestige and fully experiencing the imperial values of family, community and sustainable growth.



#### **ARTICLE 01 – Ascendants who can automatically request citizenship**

Living ancestors of Karno-Ruthenian citizens in a straight line of the first degree (paternal or maternal), second degree (grandparental) and third degree (greatgranparental) may, upon request from the citizen or by their own request, have for their benefit the granting of citizenship.

#### **ARTICLE 02 – Descendants who can automatically request citizenship**

Likewise, descendants of Karno-Ruthenian citizens in a straight line of the first degree (filial), second degree (grandfilial) and third degree (greatgrandfilial) may, upon request from the citizen or by their own request, have for their benefit the granting of citizenship.

#### **ARTICLE 03 – Regarding biological and adopted descendants**

There will be no discrimination between biological or adopted descendants for the purposes of this law.

#### **ARTICLE 04 – Regarding consorts**

Consorts of Karno-Ruthenian citizens may enjoy, upon request from the citizen or by their own request, the granting of citizenship.

#### **ARTICLE 05 – Regarding the sexual orientation of the consorts**

There will be no discrimination regarding sexual orientation for the purposes of this law.



#### **CONCLUSION**

In conclusion, the proposed bill to grant automatic citizenship to descendants, ascendants in direct line, and consorts of citizens of the Empire carries significant implications for our nation.

By extending citizenship to these individuals, the government demonstrates a commitment to inclusivity and recognition of familial ties that transcend generations.
